

EXHIBITOR INFORMATION

The KCDS Continuing Education Committee is proud of the exciting calendar of courses scheduled. We continue to offer businesses the opportunity to rent an exhibitor table, which provides you with the opportunity to meet with a large number of member dentists and their staff at one convenient location.

Vendor tables are provided on a pre-paid first-come, first-served basis. The number of tables per seminar depends on available space at the venue. Cost of the exhibitor table, including one staff member, is equivalent to the fee for a member dentist to attend the course (\$200). An additional person at the same table is charged the auxiliary fee (\$75). Fee includes beverage breaks and a buffet lunch.

While exhibitors are not allowed podium time, you will be introduced at the beginning of the day, and the forum does provide you with the opportunity to visit with attending dentists and their staff members during registration, breaks, lunch break and at the conclusion of the course. Sales are not allowed at the site of the meeting due to various regulations, but follow-up appointments may be scheduled at your convenience. Often our exhibitors encourage attendees to drop a business card in a bowl at the exhibit table, and a door prize is given away immediately after the lunch break. You are welcome to participate in the door prize drawing.

Suitability of materials and subject of exhibit are at the discretion of the Kern County Dental Society Continuing Education Committee only, and we reserve the right to select appropriate exhibitors.
